

EIN Project Protecting Freedom of Expression by Supporting the Implementation of European Court of Human Rights Judgements

EIN Conference "Protecting free speech through ECtHR judgments"

Leipzig (Germany), 20-21 November 2023

The conference aims to empower civil society and its allies across Europe to promote free speech reforms through the implementation of ECtHR judgments.

The first session will provide civil society representatives, lawyers and journalists working on free speech and media freedom with key information about the process for the implementation of European Court of Human Rights judgments and how this process can be used to bring about change through a variety of actions at national and international level, as well as with an overview of relevant judgments pending for implementation before the Committee of Ministers of the Council of Europe.

The second session will give participants the opportunity to share experiences on free speech advocacy with peers working in different European states. The purpose of this exchange will be to identify both best practices and potential risks in the context of free speech-related advocacy activities which aim at advancing the implementation of ECtHR judgments on free speech.

In the third session, participants will be invited to break out in parallel groups with the aim of acquiring first-hand experience in working on submissions to be made in the context of the implementation process and in identifying the measures to be taken to effectively implement ECtHR judgment on free speech.
